As we continue to welcome back residents to the park please remember to check in with the office upon your return.

Water utility project update:

Work continues on Easy Street as they make their way down towards Sun Up. Once they have completed the next phase of connecting the lines will take place. It is undetermined at this time if the city will continue with the work or they will hire another private contractor.

Work also continues on Idleway towards Sun Up. As of this time homes from Restful Road to Peaceful Drive on the north side are connected to the main line with new meters installed in front of the homes. Roses Lane to Dream Lane is next to be completed.

If you have any questions or concerns, please contact the office and not the contractors.

A second date has been set to hold the Annual Meeting on Wednesday, February 3rd at 2pm in the North Hall. We will be opening the sliding doors to give residents the option to sit outside (weather permitting). It is very important to make a quorum of 85 shareholders. We encourage all shareholders that are here to please attend this meeting so the voting of the Budget, By-Law Amendments and other items can be accomplished.

RULES & REGULATIONS REMINDER:

Pool Rules: Residents **only** are still in effect. No guests or children allowed. NO food or drinks allowed within 4 feet of pool. Even if drinks are in a koozie. Pool closes at 9:00pm. No pets allowed in the pool area.

Speed Limit: 15mph throughout the park. Please note your speed. It's for the safety of all of us.

Stop signs: All must adhere to the stop signs. That includes golf carts and scooters as well as vehicles.

Pet Rules: Clean up after your pet. Section IX of the Lazy Days Rules & Regulations state that it is the responsibility of the pet owner to remove and properly dispose of pet waste. This is a continued problem with pet owners not adhering to this rule. *It is important to clean up after your pet.*

Overnight Parking There is no overnight parking permitted at the halls or on the streets. If you need to park a vehicle overnight, please contact the office to obtain a parking pass. Vehicles can be towed at owner's expense.

A copy of the Rules and Regulations is available at the office.

Security Cameras: I believe there has been some misinformation in the park regarding the security cameras. Just to clarify, cameras are only in designated areas and not all around the park. I would ask that you please contact the office with any questions on the cameras and if you would like me to view a certain time and date.
