It's been busy here at Lazy Days. Some of the projects we've been working on include:

- Updating all resident files – you should have received a new Owner Information Update Form. We are using them to make sure everyone's contact information is correct and all other pertinent information is updated in your file. - Property inspections have been ongoing. This is being done to assure that residents keep their properties in tip top shape so that everyone can enjoy living here. 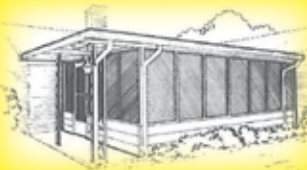

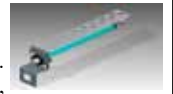
