I'm getting settled in, thanks to everyone who has been so nice and has come in and introduced themselves. The time has flown by with so many residents to meet and talk to. I'm looking forward to meeting the residents in person who will be back in the fall.



I'd like to thank everyone for helping me and sending copies of missing information. This will be used to make sure everyone's file is up-to-date and complete.

The Board approved a form to be used by residents who chose to stay at their home here at Lazy Days during a mandatory evacuation order due to weather or other unsafe conditions. The form is included here in the newsletter. That will help first responders know which properties are occupied. Please do not complete the form unless you will be here at Lazy Days during a storm event. A mailbox has been installed on the front of the office. If you are depositing the form in there, please wrap it in plastic and deposit it as soon as you make the decision to stay. If you change your mind and leave, please put a note in the mailbox to let us know. Let's keep our fingers crossed we don't have to use it.

Property inspections are continuing. I will be looking for unkempt properties, mold on houses, uncut grass and weeds in flower beds. Letters will be sent. I have a new process which includes pictures of the violation and the date the picture was taken included on the violation form.

The Board is ramping up for the fall season to start. The budget numbers are being gathered. The Budget Workshops will be held starting in November. Look for more info on that on the website and here in the newsletter.

I hope everyone has a great rest of the summer. Just think, only 3 more months of hurricane season.
